I understand that the waterski equipment being furnished includes a binding system which may NOT RELEASE at all times or under all circumstances and that it is not possible to predict every situation in which it will or will not release, and that its use cannot guarantee my safety or freedom from injury while using the waterski equipment.

I hereby agree that I will release Singapore Waterski & Wakeboard Federation and the owners and/or operators of any boat from any and all responsibility or liability for any injuries or damage to me and/or my property, howsoever caused, due to waterskiing and the use of waterski equipment and the competition waterskiing facilities. I agree NOT to make any claim against or sue any or all of Singapore Waterski & Wakeboard Federation and the owners and/or operators of any boat for any injuries or damage to me and/or my property relating to waterskiing and the use of water ski equipment and the competition waterskiing facilities.

- d. Carry litter with me if I cannot find any trash bins nearby.
- e. Try to pick up litter that I find on the water, whenever possible. If the litter cannot be retrieved, I will report it to my coaches or relevant authorities.
- f. Not to swim, or place any part of my body in the water when not wakeboarding/waterskiing.
- g. Not to urinate in the reservoir.
- h. Not to smoke at the reservoir.
- i. Wear a life vest at all times if standing/sitting on floating dock or in the boat.
